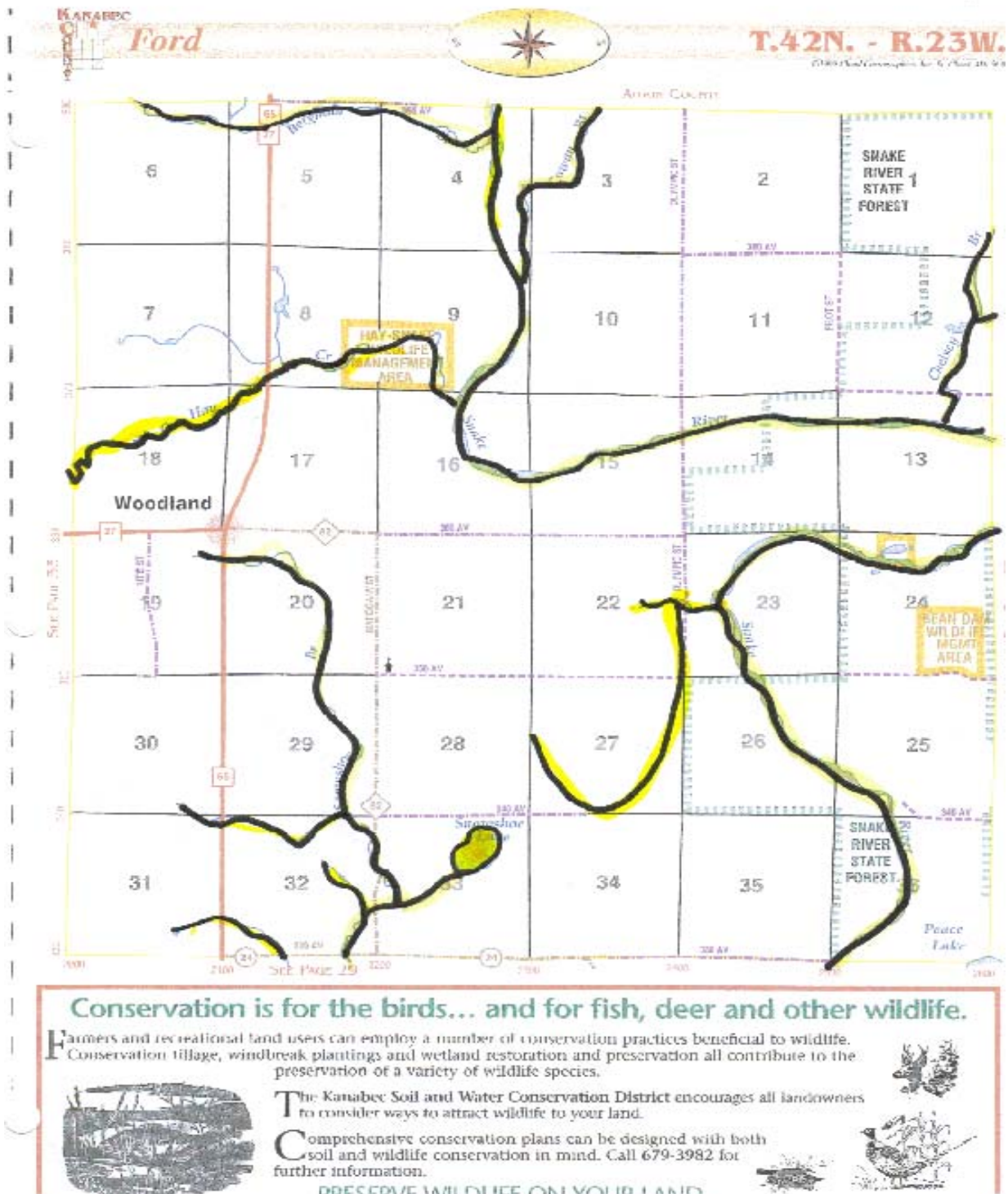


## **Appendix A: Shore Land & Tributary Waters**

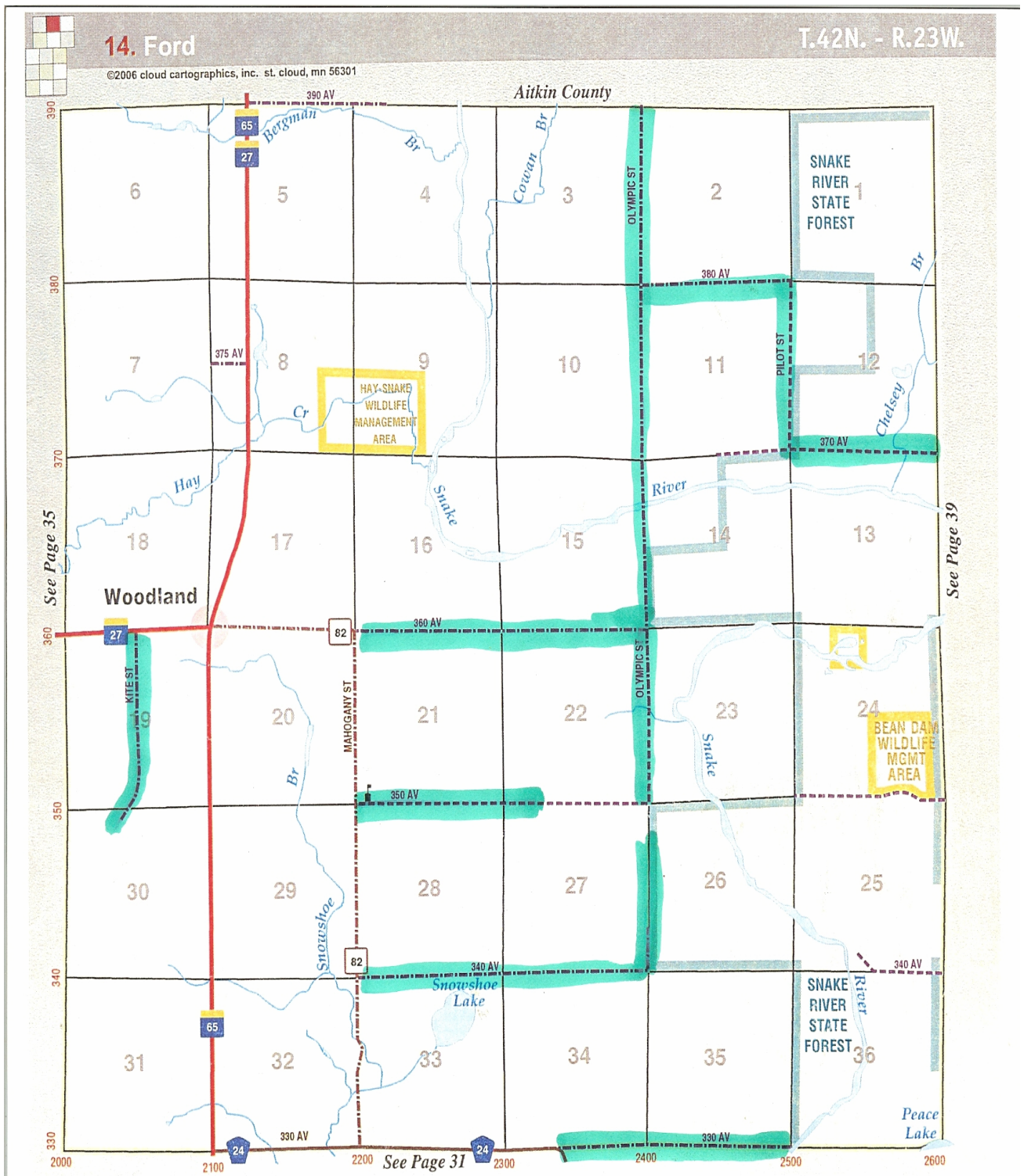

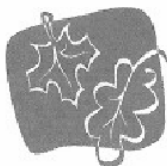
## **Appendix B: Ford Township Road Map**

The Comprehensive Plan is comprised of five areas: land use, public facilities and infrastructure, housing and economic development, agriculture and natural resources, and heritage, recreation and quality of life.
